RE: Comments on Issue Paper posted by APA on June 24, 2014

Gentlemen:

As you know, I represent generally before the APA Commission six current Hoover customers, specifically, Aguila Irrigation District, City of Safford, Electrical District Number Eight, Harquahala Valley Power District, McMullen Valley Water Conservation & Drainage District, and Tonopah Irrigation District.

You also are aware that I have participated actively over the past several years in the federal and state political and administrative processes generally referred to as the "Post-2017 Hoover Reallocation" on behalf of these customers.

In recent continuation of that effort I have attended the various public workshops sponsored by the Commission and its consultants, and have provided both oral and written comments in each such forum. Accordingly, I participated in the June 30, 2014 workshop reviewing the Issue Paper posted on the Commission's website on June 24, 2014. I also intended to submit written comments on that Issue Paper before today, as requested by Chairman Brophy.

Unfortunately, early on the morning of July 19th, I had a serious bicycling accident in which I suffered a severe concussion, one broken vertebrae (not serious), a bruised lung and numerous severe abrasions, contusions, and a major hematoma. I have been effectively incapacitated since the accident. I am still out of state trying to recuperate at the home of a daughter and M.D. son-in-law. While I have made a measure of reasonable progress toward recovery (not nearly enough for my liking), the injuries have resulted in my being heavily medicated (thus foggy even beyond my normal degree...) and unable to prepare written comments on the Issue Paper specifically on behalf of the above-listed customers for submission today.

Consequently, I respectfully and appreciatively ask your consideration of two requests:

- First, please consider this email to be an expression of support by the above-listed customers for the written comments submitted separately today by Sheryl Sweeney, Mark McGinnis, and Bob Lynch/IEDA on behalf of the other Hoover

customers and organizations they represent, respectively, copies of which comments they have graciously shared with me.

- Secondly, I will appreciate the measure of consideration that you deem appropriate for such additional written and oral comments as I will yet submit regarding the June 24 Issue Paper or otherwise in this ongoing informal process, as well as in the eventual formal allocation process.
